


Fig. 1) Climate-related displacement in a forced (f) to voluntary (v) mobility continuum.





Fig. 2) Global new displacements due to conflict or disasters (2008-2019).

# Climate displacement is dynamic and shaped by compound vulnerabilities.




Fig. 3) ERA5 monthly anomalies on precipitation (left) and temperature (right) compared with climatology period 1981-2010 looping through Jan 2016 to Dec 2019.

# Attribution of climate change and human mobility such as displacement?

#### - Problem:

Increased climate-related forced migration is often portrayed as a key impact of anthropogenic climate change.

#### Is there an attributable link? NO.


- Human mobility is **context specific** and **climate never the sole driver of mobility**.
- causal, quantitative evidence on this link remains sparse and suffers from disciplinary hurdles.

# Food security is a prevalent need for climate displaced people across Somalia.




Fig. 4) Top 5 priority needs across Somalia (2016–2019). Source: UNHCR 2020.


### Top 5 priority needs:

But how can we prepare for the emerging food security crisis?














### Forecast based financing (FbF) or: Anticipation instead of reaction.

### Definition

**FbF** enables access to humanitarian funding for pre-disaster action, based on climate and weather forecasts, combined with risk analysis.

#### Takeaways

- We know the <u>types</u> and <u>spatio-temporal</u> <u>components</u> of priority needs of displaced people in recent years;
- This knowledge allows us to create <u>forecasts</u> on near-term priority needs across Somalia.
- COVID-19 relevance: provide urgent response before compound extremes and climate-related displacement cascade.










